Digital Sign Purchase

REASON FOR CONSIDERATION BY THE BOARD

College policy states that the Board of Trustees' approval is normally required for items costing in excess of \$19,999


BACKGROUND

We have learned of the opportunity to purchase and install a digital sign using C.A.R.E.S. Act funds to aid in the communication of needed COVID related information. The sign would be placed on the Cardinal Event Center corner and would allow us to display more information about mask requirements at face-to-face events, as well as virtual events. This would replace our current row, scrolling sign north of Zetmeir on Main Street which severely limits our messaging capabilities. CARES funds cannot be used to remove the current scrolling sign and replace with matching brick, however, we believe the cost would be minimal.

CDL Electric has agreed to a cost of \$32,048 and are able to meet the time constraints imposed due to the C.A.R.E.S. funding.

PRESIDENT'S RECOMMENDATION

The President recommends the Board of Trustees forgo the normal bid process and approve the purchase of the digital sign from CDL Electric at a cost of \$32,048 utilizing CARES funds.

Install (2) new pan faces with painted and embossed letters and graphics using customer approved artwork. Faces measure approximately 5'H x 11'W

Install (2) new 16mm full color, borderless OPTEC INFINITY LED Electronic Message Centers as shown in the approved rendering. Install wireless antennas on LED sign and building. Paint pole and upper cabinet (Color TBD). Make final electrical connection to LED signs and upper cabinet. This bid does not include any service or repair to the electronics in the upper cabinet. An LED retrofit of upper cabinet is recommended and can be done separately after the number of lamps are determined and is not included in this proposal. Price includes software installation on customer's PC and training provided by OPTEC. Initial video message content provided by OPTEC graphics department. LED signs will have cell modern plus LIFETIME data package for remote access to the LED signs. 5 year parts warranty from OPTEC. Cell modern carries a one year manufacturers warranty. LED signs measure 3'-11"H x 7'-1"W

Ensure proper operation of all sign electronics. Clean work area.
