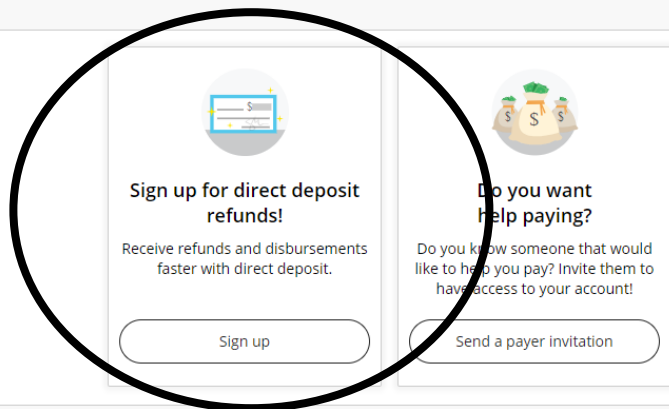

- Login to RedZone and make sure you're on the Student tab.
- Select Financial Aid and Account Information to the left side of the screen.
- Scroll down until you see a black button that says Go to Transact Payment Plans, this will take you to the Transact site.



Once you're in Transact, scroll down until you see the Sign up for direct deposit refunds! option and click Sign up.

1. It will take you to the Terms and Conditions, which you'll need to agree to and use your ID number to sign with.
2. The next screen will have all the information you'll need to enter, including the account type, account number and routing number for the account you want any refunds to go to.
3. Then you'll click Continue and it will have you verify the information that was entered. If it's correct, select Complete and you're all done!
