





PRESIDENT'S RECOMMENDATION

That the Board of Trustees review Policy 2.10 Drug and Alcohol Abuse Prevention and Policy 4.112 Military Connected In-State Tuition Benefit. Approval is recommended.





POLICY 2.10 DRUG AND ALCOHOL ABUSE PREVENTION

To ensure that the College is in compliance with local, state, and federal laws, and judiciously expends public funds, this policy is established. Furthermore, Labette Community College (LCC) is in compliance with the Federal Workplace Act of 1988 and the Drug-Free Schools and Communities Act Amendments of 1989.

A. Definition of Terms:

- 1. "College property" means any property owned, leased or rented by Labette Community College including hotel rooms, rental cars, and meeting rooms or facilities rented by the College on a short or long term basis.
- 2. "Alcoholic beverages" as used in this policy, mean beverages which are alcoholic liquor or cereal malt beverages as defined in Kansas Statutes.
- 3. "College funds" mean any funds managed and controlled within the College's financial accounting system. Funds of the LCC Foundation are not included in this because they are not directly controlled by the College.

B. General Regulations

- 1. Alcoholic beverages may not be consumed on College owned or leased property or in a College-owned or leased vehicle.
- 2. As a general operational policy, alcohol may not be purchased with College funds.
- 3. College employees or students may not operate a College owned or leased vehicle while under the influence of alcoholic beverages or illegal drugs or while impaired by the use of prescription medications.
- 4. College employees or students may not transport fellow employees or students or drive in a personally owned or leased vehicle while under the influence of alcoholic beverages or illegal drugs or while impaired by the use of prescription medications while on College business or on a College sponsored trip.
- 5. College employees or students may not be on College owned or leased property while under the influence of alcoholic beverages or illegal drugs.

C. Exceptions

1. Alcohol may be served at select events in the Cardinal Event Center with written permission from the College President.

2. Request to serve alcohol at an event in the Cardinal Event Center must be made in writing to the College President at least two weeks in advance of the event.

D. Violations

Employees or students who violate this policy are subject to applicable disciplinary actions. Violation of section B-3 & 4 above will be considered a serious offense and may be punishable by termination or expulsion for a first offense. Please refer to Policy 2.16 Performance Improvement.

The College may file complaints with local law enforcement agencies or ban members of the general public who violate this policy.

Procedures in support of this policy must be approved by the President.

POLICY 4.112 MILITARY CONNECTED IN-STATE TUITION BENEFIT

Per the Choice Act of 2014 and the State House Bill 2154 and 2567, Labette Community College will offer the in-state tuition rate to qualified individuals.

Qualified individuals include:

- Current members of the armed forces* of the United States
- Spouses and dependent children of current members of the armed forces* of the United States
- Veterans and their spouse and dependent children who were permanently stationed in Kansas during their service in the armed forces**
- Veterans and their spouse and dependent children who had established residency in Kansas prior to service in the armed forces**
- Veterans eligible for VA educational benefits (Post 9/11, Montgomery, Chapter 1606/1607 reserves)**
- Spouses and dependent children of veterans with entitlement to a VA educational benefit (Post 9/11, Fry scholarship, Chapter 35 DEA)**
- *The term "armed forces" includes the army, navy, marine corps, air force, coast guard, Kansas army or air national guard or any branch of the military reserves of the United States.
- ** Requirements: Must live in Kansas while attending school.

Note: It is not a requirement to use the VA educational benefit to receive the in-state rate. Instate rate continues even after benefit has been exhausted with continuous enrollment.

Questions and inquiries regarding instate tuition are handled through the Military Connected Coordinator or the Admissions Office.



PRESIDENT'S RECOMMENDATION

That the Board of Trustees review Policy 2.09 Use of Tobacco/Nicotine/Vaping Products. We will request action to be taken at the January Board Meeting.



POLICY 2.09 USE OF TOBACCO A STATE OF PRODUCTS

Labette Community College recognizes scientific evidence, which indicates that the use of tobacco/nicotine/vaping products is harmful to the health of the user. Scientific evidence also shows that smoking of tobacco products is known to be harmful to others who, due to close proximity with smokers, become "passive smokers" without choice. In addition, use of smokeless tobacco products creates cleanliness and sanitary problems. With the Kansas Indoor Clean Air Act, K.S.A. 21-6109 and 21-6116, the campus is a public place and therefore required to be smoke free.

For these reasons, in conjunction with its mission to provide quality learning opportunities in a supportive environment, Labette Community College is a tobacco-free institution. The College employees, students, and visitors will share in the respectful adherence and enforcement of the tobacco-fricotine/vaping free policy.

Specifically:

- Tobacco use in any form and/or vacing electronic cigarettes including but not limited to
 <u>nicotine delivery devices is are</u> prohibited on all College-owned property and within
 leased College office, classroom space and vehicles. The use of all tobacco and <u>niceture</u>
 <u>delivery devices and products, vaping products are is</u> prohibited on College-owned
 facilities and facilities leased and controlled by the College.
- Tobacco and nicotine delivery devices and vaping products use areis prohibited in all
 indoor and outdoor facilities, including athletic fields, entrance steps and ramps,
 restrooms, pedestrian walkways, entryways, portable buildings, and in privately owned
 vehicles on college property.
- Tobacco and nicetine delivery devices and productand vaping product use is prohibited, other than in designated smoking areas, at meetings and conferences sponsored by Labette Community College or during any travel sponsored by the College.

Procedures for implementation of this policy will be determined by the President.


Part of the Board's responsibility is to maintain oversight on the quality of the academic and administrative programs and services. This has been an on-going feature of our regular Board meetings.

Executive Summary

(Include the major changes from previous program review.)

The purpose of a five-year Program Review is to evaluate the viability and quality of a particular program and institute a process to improve services to our students and supporting constituency. The Program Review committee has reviewed the appropriateness of the action plan.

Program Review committee members included the lead faculty as well as other faculty, staff, and the Dean of Instruction. Program data were collected and analyzed for program relevance, quality, and effectiveness.

- The committee reviewed progress from the 2015 Program Review.
- The biology department has updated its course offerings. All the biology courses in the program are recently realigned to match the KCOG approved courses that will transfer seamlessly to all the KBOR institutions.
- Two faculty members in the department serve as co-advisors in the Biology Club. It will serve as a platform for student engagement outside the classrooms and hopefully, will serve as a tool in retention of declared majors.
- The biology department has a strong working relationship with the health science programs. The department offers some of the prerequisite courses to enter into health science programs. These courses provide students a solid foundation and prepare them well to succeed in those fields.
- Biology faculty members participate in the annual Kansas core outcome meetings.

The committee identified program strengths which include:

- Three well-qualified faculty members, two with a PhD degree and one with Masters in biological field.
- Faculty members who are members of national societies, participate in professional development opportunities, and are recognized in their fields.
- The four program courses that are aligned with the KCOG course offerings for seamless transfer to any Regents institution.
- Class offerings by full time faculty members in both the campuses (main campus and Cherokee Center), in all three formats (on ground, hybrid, and online), and during the day-time and evenings.
- Course offerings that are prerequisites for entering into health science fields.
- Partnerships with local high schools with concurrent course offerings

The biology Department offers several courses and maintains excellence in every course. The courses offered are all transfer courses to Regent schools. Labette Community College's Health Science Department is one of the best in Kansas and about 80% of the Health science students take courses such as Biology, Anatomy and Physiology, and Microbiology. Students who are biology majors, biology minors, and pre-professional students who enter into pharmacy, medical technology, physical therapy, occupational therapy, mortuary science, dentistry, osteopathic medicine, pre-medical students, and other biology fields, take courses from the biology Department. Additionally, many Associate of Arts, Associate of Science, and Associate of General Studies majors take courses from the biology Department to fulfill their science requirement.

MISSION STATEMENT

The biology program at Labette Community College provides students excellent opportunities for students to be prepared for a career in the biology and related fields and to successfully transfer to a four-year university. The courses completed at LCC seamlessly transfer to any Kansas Board of Regents institutions. Due to small class sizes, capped at 22-24, students have more opportunities to get individual attention and interact with faculty.



■ Full Time ■ Adjuncts





REVIEW COMMITTEE IDENTIFIED WEAKNESSES/OPPORTUNITIES/CHALLENGES

Discuss the major weaknesses, opportunities, or challenges of the academic program/discipline.

Weaknesses:

- The data indicates that the students who start as biology majors do not complete the degree. Students start at LCC as biology majors and a majority of these students simply complete the prerequisite courses to apply into health science programs. Some of them transfer to other schools and others change their majors.
- The storage room in M 106 classroom needs maintenance. The floor and the doors to the storage shelves are in bad condition and require maintenance or change.
- The current location of whiteboard in M 106 prevents the full use of whiteboard and the projector screen simultaneously. The whiteboard should be shifted to the left so that there is minimum overlap between the projector screen and whiteboard.

Opportunities and Challenges:

- To meet the demand and to maintain quality course offerings there is a lack of qualified adjuncts in SEK.
- All of the Regent institutions require at least one science course as part of the general education requirements.
- To reduce the cost but still be able to provide the quality lab experience to the online students, the program faculty is considering replacing online kit with the virtual labs for our non-major class.


